

row will be Courts 8–11. Courts 12 and 2 will be in the  
third row as in 2009. This means we will have 17 courts  
available for play this year (as there is no Court 13)—  
reverting to 19 courts in 2011.*

coming into our Grounds but, as always, I am certain  
that you will understand the need to protect the safety and  
security of all our players and visitors.*



# GENERAL



## BANK

HSBC Bank is located just to the north of Gate 3 at Level -1 of the Museum Building. Opening hours are 10.30 a.m. until 8.30 p.m. each day. Two ATM's are located outside the Bank.

## CHANGES FOR 2010

### BAND

- ★ Music on the final two days will be provided by The Central Band of the Royal British Legion.

### COURT NUMBERS

- ★ The designated 'Show Courts' will be Centre Court, No.1 Court, No. 2 Court and Courts 5 (with a temporary stand built on the incomplete Court 4), 12 (with a large temporary stand on the west side) and 18. Although the work on the new Court 3 and the 'facilities' building will not be complete until the 2011 Championships, the southern courts have been re-numbered in preparation for 2011. The front row of courts, outside the Clubhouse from the west, will be Courts 3 and 4 (neither in play for 2010), Courts

5, 6 and 7; the second row, from the west, will be Courts 8-11 and Courts 12 and 2 will be as per 2010. There will be no Court 13.

### LOST PROPERTY

- ★ Lost property will be located in the North West corner of the new Court 3 building near Gate 13.

### ENTRY TO THE GROUNDS

Public admission to the Grounds is from 10.30 a.m. daily during The Championships.

Media admission can be earlier providing they restrict their whereabouts to the Media areas. The Press Centre will be closed at midnight during The Championships.

On the middle Sunday (27th June), the press working areas will be open from 11.00 a.m. to 4.00 p.m. Those wishing to use this facility should inform the Press Operations Manager by 6.30 p.m. on Saturday 26th June.

### HAND LUGGAGE RESTRICTIONS

Bag restrictions will be in place for all ticket holders, whether advance or on-day sales. One bag per person will be allowed; this bag must measure no more than 18" x 12" x 12" (45cm x 30cm x 30cm) and no hard-sided hampers, cool-boxes or briefcases will be allowed into the Grounds.

### INFORMATION SYSTEMS

- ★ These will be available in the pigeon holes on all three levels of the Press Centre.

- ★ Transcripts and score sheets from previous Championships are stored in the Museum.

#### NON MATCH RELATED QUESTIONS/ PUBLIC RELATIONS

- ★ The Public Relations team is available to give an official response from The Club on matters and to answer any non-match related questions.

#### PLAYER INFORMATION & STATISTICS

- ★ Are provided by the ITF (Men's Tour), the WTA and IBM staff, who are all located in the main press reception area.

#### RESULTS SERVICES

- ★ Point by point scores are sent from all courts to a central computer in the Referee's Office and then to TV monitors around the Grounds.
- ★ Boards with up-to-date results, written in the colour of the day, are displayed on all floors of the Press Centre.
- ★ Copies of score sheets can be collected from the pigeon holes by the Press Reception Desk on all floors of the Press Centre.
- ★ Detailed statistics of Show Court matches are available from IBM, while those of outside courts can be obtained on request.

#### TV MONITOR ROOM

- ★ Twenty screens cover the BBC Championships

transmissions and fixed camera feeds (no sound) of all Show Courts, six further outside courts, player interviews plus point-by-point scores from every court, as well as the Player Interview Schedule.

- ★ Play-backs of recorded interviews are available on application to the Press Interview Control Room.

Accredited Members of the Media may visit the Museum between 10.30 a.m. and 8.00 p.m. during The Championships without charge. Accreditation gains admission and must be shown when entering the Museum. The Museum is accessed through the Wimbledon Shop, adjacent to Gate 4.

# PLAYER INTERVIEWS



## PROCEDURE

The All England Lawn Tennis Club wishes to emphasise that player interviews are intended to be about tennis and if questions are asked which a player does not wish to answer, because they are of a personal nature or are provocative or repetitive, the Club will support any player who does not wish to complete the interview. All interviews must be conducted through the official channels. The Player Interview procedure is set up to minimise the number of locations and time for Press, Television and Radio interviews and press conferences.

## INTERVIEW POLICY

- ★ Only appropriately accredited journalists and broadcasters, may attend interviews in the Press Interview area. Competitor's guests, including relatives, friends and coaches, may not attend this area except with express Media Sub-Committee authority. Even when permission is granted it will be conditional that the guest takes no part in the interview.
- ★ No one (including competitors) may hold Press

Conferences within the Press Interview area without advance permission from the Media Subcommittee. In the event of permission being granted, the Conference will be open to all appropriately accredited Media representatives.

- ★ No person may hold a Press, Television or Radio interview within the Press Centre except through the AELTC's interview system.

### INTERVIEW ROOM

- ★ The Main Interview Room is on the Ground floor (Level 2) of the Press Centre, accommodating 160 press, including television and radio personnel whose passes have been endorsed with the word 'Interview'.
- ★ No individual microphones will be permitted on the Players' Interview Podium, sockets are provided on the rear wall to enable all interviews to be recorded.
- ★ No television cameras are permitted.
- ★ There is no access from the main Interview Room to the BBC One-to-One Studios except via the special security manned door.
- ★ The waiting area adjacent to the main Interview Room is equipped with audio feeds of the player interviews (on headphones) and a game-by-game monitor with updates on all courts.
- ★ Simultaneous translation will be provided in certain circumstances. The provision of this service will be entirely at the discretion of the AELTC.

### ORDER & TIMING OF INTERVIEWS

These are as follows:

1. General Conference in the main Interview Room—10 minutes.
2. One-to-one BBC TV in their studio at the conclusion of the conference above—3 minutes maximum.
3. Priority for subsequent one-to-one interviews will be given to broadcasters from the player's country of origin—3 minutes maximum.
4. Subject to player agreement, other one-to-one or group TV, Radio and overseas press interviews in an allocated Interview Area on Level 2.

#### *Note*

- ★ One pool photographer will be allowed in the Interview Room during interviews.
- ★ Television news organisations will have access to record or receive recordings of the Player Interviews. Details about this are available from the Broadcast Liaison Office.



# THE LONG TERM PLAN

Since the 2009 Championships, work has progressed at the southern end of our Grounds towards the creation of a new Court 3, together with a new Court 4 on the other side of the extended St Mary's Walk.

*New Court 3*, a 2,000 seat open bowl stadium, with commentary and TV camera positions and two large screens, will be opened in 2011. Underneath the terracing will be amenities such as public toilets and a lost property office.

*New Court 4*, like new Court 3, is also scheduled to open in 2011, but for 2010 the concrete base will take a temporary grandstand to enable Court 5 to be scheduled as a show court.

*St Mary's Walk* is the major pedestrian access route running from the top of Aorangi Terrace past Centre Court down to the southern courts. For 2010 it has been extended to the south end of Court 8 to make it much easier for spectators to move around this part of the Grounds.

As part of the same project, other facilities at the southern end of the Grounds are also under construction, including a single storey Facilities Building, as well as a new Groundsman's Office, Maintenance Workshop and related storage.

#### PRESS RECEPTION DESK

**Opening hours are 9.00 a.m.–10.00 p.m. during The Championships except for the first Monday when the reception is open from 8.30 a.m.**

*Please note that smoking is not permitted inside the Press Centre. There will be no smoking allowed anywhere in the press restaurant area (indoor or under cover) on the fourth floor in compliance with the new regulations that came into force in July 2007.*

*There is an area outside the middle floor writing room or in the Press Courtyard where smokers may like to congregate.*

#### CHILDREN

Children under the age of 12, even babes in arms, are not permitted in any part of the Press Centre at any time.

Children over the age of 12 must be accompanied by an adult at all times. They are not permitted in any of the press working areas at any time.

#### DESKS

Power is supplied through 13 amp 3 pin sockets. Telephones (pre ordered with Mac Systems) and television

sets providing 33 channels covering all 18 courts, interviews, results, statistics and four national channels are also incorporated in the desks.

Each desk has a lockable drawer, keys may be obtained at a charge of £5. *Writers are responsible for their own security.*

#### GUESTS

Please inform the Press Office staff if you are expecting a guest. Daily wristbands will be issued for guests and must be worn to gain access to the Media Centre. It is the journalist's responsibility to collect these. We would also request that journalists limit the number of guests to a *maximum of three at any one time.*

Guests are not allowed in the working areas during the hours of 3.00 p.m.–6.30 p.m. At any other time they must be accompanied by a journalist.

#### INFORMATION SUPPLY & DISTRIBUTION

Pigeon holes are sited on all three floors of the Press Centre and Press Office for score sheets, interview transcriptions and press information. Any urgent announcements will be made over the public address system. The Wimbledon Press Office team is supported by the WTA Tour, the ITF (on behalf of the men's tour) and IBM. Information relating to matches and players can be obtained from these sources.

Questions not directly related to tennis, e.g. Club policy, fashions, catering, floral arrangements, should be referred to AELTC Public Relations whose offices are on Level 3.

## INTERNATIONAL TELEPHONE & FAX SERVICES

Six credit card telephones with modem connections for data transmission and three fax machines are available for use by international press. Telephone cards can be purchased from the International Press Liaison Officer. All fax transmissions will be logged in a register and will be charged at a rate of £1 per minute by the International Press Liaison Officer whose desk is in the room.

For those staying at the Ibis hotel there will be a daily pick up service at 9.30 a.m., 10.30 a.m. and 11.30 a.m. only. There will be a limited service running on the weekend prior to The Championships from the Copthorne only. The service will run on Saturday 19th June at 10.00 a.m. & 11.00 a.m. inward and 4.00 p.m. & 5.00 p.m. return; and on Sunday 20th June at 9.30 a.m. & 10.30 a.m. returning 3.00 p.m. & 4.00 p.m.

For those wishing to use public transport, the nearest underground station to the Copthorne hotel is Fulham Broadway and the Ibis Hotel is West Brompton (both District Line) which goes to Southfields/Wimbledon.

As in previous years, upon request there will be the facility during the evening service to drop people in Wimbledon Village en route to Stamford Bridge.

*Please note there will be no transport service to the Gloucester Road area nor the Novotel Hammersmith.*

#### WI-FI SERVICES & INTERNET CONNECTIVITY

Once more WI-FI facilities and Internet connectivity will be available at The Championships on the same basis as previous years for the Written Press. For The Championships 2010, it is the intention to offer the service free of charge, to those who wish to participate. The AELTC have once more invested in further equipment and facilities for 2010 in order to maximise the potential of the WI-FI scheme which will hopefully continue to offer a robust and efficient system.

To this end those wishing to participate and use the facilities have been required to register their interest on their application form, as there is a need to be able to plan for the usage.

**Registration at The Championships**—Each user at The Championships will then, via the IBM Press Desk, be given the necessary information to enable access to the network. Support personnel will be on hand to offer assistance if required. You will be required to sign the relevant documents, similar to those provided at last year's Championships, before access is granted.

The AELTC would like to remind *all* users of the Internet and the WI-FI system of their obligations relating to the installation of updated anti-virus software on their machines prior to signing onto the network.

## CENTRE COURT PASS

Overprinted 'Centre Court' with a numbered seat, receives priority over all other press passes in press seats on all courts. Journalists must sit in their allocated seat on Centre Court for the last four days of The Championships.

### CENTRE COURT (ACCESS 9 DAYS)

Overprinted 'Centre Court (Access 9 Days)' grants Centre Court access for the first nine days only. *It is valid for all 13 days of The Championships elsewhere in the Grounds.*

## ROVER

Overprinted 'Rover' allows the pass holder anywhere in the Grounds on all 13 days, as well as access to press seats on show courts if there is space. Holders must give way to Centre Court and 9 Day pass holders if necessary.

Access to Centre Court and No.1 Court is by an extra 'hanging badge' available from the press desk on the day in question.

## DAY ROVER

Passes overprinted 'Day Rover' allow the holder into the Grounds and press areas on the day specified on the pass.

## TECHNICIANS

Yellow photopasses admit press technicians and engineers to the Grounds and their place of work only. No access is permitted to the Press Seats on any courts.

## ACCESS TO COMPETITORS' RESTAURANT

Full members of the International Tennis Writers' Association (ITWA) and specialist tennis writers are allowed access to the Competitors' Restaurant at the discretion of The All England Club.

All other *tennis writers* who do not fall into these two categories may apply to the Press Office for access to the Competitors' Restaurant, stating their specific reason. A limited number of special passes will be issued for 40 minutes. Recipients who fail to return the pass within this time will forfeit future rights to this privilege. *News reporters are not granted access.*

## ACCESS TO AORANGI PRACTICE COURTS

Only Centre Court seat holders, full members of the Lawn Tennis Writers' Association (LTWA) and full members of ITWA are allowed direct access to the players' area overlooking the Practice Courts.

Other *tennis writers* may apply to the Press Office for a special pass. As with the Competitors' Restaurant,

the time limit will be restricted to 40 minutes. *News Reporters are not granted access.*

During middle Sunday there will be very limited access granted to the Practice Courts. This will be by special Pass issued for a limited amount of time (30 minutes) for all journalists. *News Reporters are not granted access.*

#### ACCESS TO REFEREE'S OFFICE

No member of the Press is permitted direct access to the Referee's Office. Full members of the ITWA and ITWA may be allowed access to the Lower Referee's Office *but only by prior arrangement.*

#### IN GENERAL

During the final few days of The Championships a reserve list for seats on the Centre Court is organised in order to fill any seats which are not taken up by the named organisation. If you know you will not be present during the last 4 days, please inform the Press Office.

If you have any special requests, please ask for help at the Press Reception Desk or direct your enquiry to the Press Operations Manager where required.

#### WET WEATHER—CENTRE COURT ACCESS

During the first week, if there is play solely on Centre Court, initially the only pass that will gain access will be a Centre Court pass and seating will be on the first come first served basis. It is important to recognise that there will be more Centre Court passes than seats available hence the 'first come' rule during week one.

#### RADIO ACCREDITATION

Once again at The Championships 2010 we are offering two levels of licensed Radio News Access levels. This is for various reasons, not least that Radio Broadcasters seem to need a variety of options to achieve their news coverage. As exclusive Primary Radio Rights agreements and new media outlets develop in the modern radio world, News Access licences must be in place to protect exclusivities and address this diversity. At the same time, the Club is very mindful of the exposure the News Access broadcasters provide and hopes to continue a high level of service for all those who cover tennis.

#### RADIO

#### RIGHTS HOLDER—RESTRICTED TERMS & CONDITIONS

*to be read in conjunction with the enclosed rate card*

(To be granted subject to the agreement of the Territory Primary Radio Rights Holder, if there is one).

1. This licence is granted, subject to payment of rate card fees, solely to permit the licensee to create short audio reports of The Championships 2010 (21st June to 4th July). It is not intended to form the basis of long form programming.

2. ALL reports shall be retrospective.
3. There will be no live ball-by-ball commentary or live descriptions of ceremonies at any time.
4. During The Championships (first to last competitive ball struck in the main draw. For these purposes main draw means the Men's and Ladies' Singles, the Men's and Ladies' Doubles and Mixed Doubles). Licensee is permitted a maximum of 6 minutes per hour of play per station for reporting purposes +1 minute of player interview material with players in the main draw. Interviews with players in other draws have no restriction. However, no single report can be longer than 2 minutes. Licensee's reports can only be heard on the internet as part of the radio's normal output simulcast on its own website.
5. Licensee is permitted unlimited broadcast time to report background and colour pieces but reporting of play and inclusion of player interviews are restricted as set out in 4 above.
6. Licensee may book a Radio Reporter's Position on Centre Court at rate card prices. Availability is on a limited basis and therefore a position cannot be guaranteed until confirmed by the Club.
7. Licensee's reports cannot be sponsored without the prior written approval from the Club. Such approval to be sought at least one month before the beginning of The Championships, however, there can be no association whether directly or indirectly with betting or gaming bodies.

8. Licensee will have no official affiliation with The Championships, nor can Licensee use the Official Marks/logos except for editorial non commercial purposes only.
9. Licensee can participate in Press Conferences and can request a Group Interview, subject to the terms and conditions set out here, in order to obtain a short audio clip in Licensee's own language. The clip used must not exceed 1 minute. This may be granted (subject to player and the Club's Representatives approval) when all other tv and live full commentary Radio Rights Holding interviews have taken place. Licensee will only interview players in the official player interview area.
10. Main draw player interview clips of no more than one minute each can be posted and/or archived onto any Internet or extranet site (for the accessing of material by Licensee's station/s) subject to prior approval in writing from The Club and provision of user name and password to monitor such distribution.
11. Where the use of Championship material is approved and made available on a web or extranet site, a prominent link to the Official Site must be provided on the appropriate page.
12. Licensee is asked to list including web address and login details where appropriate of all Licensee's radio stations and Internet sites for which Licensee is working on Licensee's application form. Licensee is not permitted to sublicense its material to any station

or audio outlet not on this list. Non compliance with this clause could result in the withdrawal of Licensee’s accreditation, and Licensee will be liable for any damages suffered by the Club as a result of such breach.

- ★ There are no facilities for Radio Newscasters to interview players in the Press Interview Room or in the adjacent areas.
- ★ No Radio Newscasters' individual microphones are permitted on the Players' Interview Podium.
- ★ Recordings of the Player Interviews can be made by using wall sockets installed at the back of the Interview Room (both 5 pin male din and XLRs) as well as sockets tied to the set-top box on the televisions in the Newscasters' Boxes.
- ★ There will be no access from the Interview Room to the One-to-One Studios except via the special security-manned door.
- ★ One-to-one interviews may only be recorded if a player gives express permission. Any person accredited for, or acting on behalf of, a radio station or indirectly through a publication, will be bound by the radio restrictions which may be in force in a particular territory.

All Applications for Accreditation Forms are to be returned to us by Thursday 11th March 2010 to enable us to issue acceptance letters by mid-April. Those accredited to the 2010 Championships are:

*Daily Newspapers*

*Evening Newspapers*

*Sunday Newspapers*

*International Wire Service and News Agencies*

*Radio Reporters accepted under licence granted from the Club*

*Specialist Tennis/Sport Magazines*

Priority is given to those journalists/radio reporters filing daily reports for the Fortnight. Their applications should be supported by the Editor or Sports Editor in writing on the notepaper of the publication or organisation concerned. **No un-headed letters will be considered. No application from freelancers or ghost writers will be accepted.**

Accreditation is a privilege, not a right. The AELTC may grant or reject or revoke accreditation at any time at its absolute discretion. Accredited applicants are subject to

the AELTC Terms & Conditions of Entry. The applicant agrees not to interfere with other media/rights holders, spectators, players or play at The Championships.

Passes are strictly non-transferable and must be worn at all times. They remain the property of the AELTC.

## WRITTEN PRESS

1. The Committee cannot guarantee the granting of accreditation based on a previous year's accreditation or retention of a Centre Court seat or facilities by a publication or individual on an annual basis simply because of previous tenure.
2. While regular representation is a primary factor, circulation, national interest, player representation, sports coverage and numbers of applications are all factors which the Committee take into account when granting accreditation for the facilities available.
3. Applications are reviewed at the discretion of the Committee whose decision is final, but it should be noted that because of the increase of worldwide interest in The Championships the Committee may consider accreditation from countries not adequately represented.
4. During the last four days of The Championships, writers in the Centre Court press box must ensure that they watch from their allocated seats.

## INTERNET

5. The Committee does not grant accreditation to journalists writing solely for the internet. The

Photographer accreditation will be granted upon the express condition that the photographer (and/or copyright holder) has signed the Terms & Conditions contract, a copy of which is printed on pages 102–108 of this guide.

### WI-FI & INTERNET CONNECTIVITY

As in previous years, WI-FI and Internet connectivity will be available at The Championships on the same basis. As before, it is the intention to offer the service free of charge for this year, to those who wish to participate, but also as in previous years, we cannot guarantee coverage however the AELTC have invested in further equipment and facilities for 2010 in order to maximise the potential of the WI-FI scheme which will hopefully continue to offer a robust and efficient system.

To this end those wishing to participate and use the facilities have been required to register their interest as there is a need to be able to plan for the usage.

You will be required to sign the relevant documents, similar to those provided at last year's Championships before access is granted. There will also be certain restrictions placed on the access numbers, hence all enquiries and requests should be made through Bob Martin.





Should your application for accreditation be successful, during your time at The Championships there are as always some guidelines and rules. To make everything completely clear to both sides we have produced the following document:

*The Photographer (on his/her own behalf and, where he/she is an employee, also on behalf of his/her employer), agrees, as a condition of his/her being allowed accreditation for The Championships, that the following terms and conditions will be strictly adhered to and recognizes that any infringement can and will lead to the accreditation being withdrawn permanently:*

**TERMS & CONDITIONS**

- 1 The use by Photographer or any third party authorised by Photographer of the photographs shall also be strictly in accordance with the following policies:
- 2 Photographs may be used or syndicated only for *editorial purposes* in printed/press media form and no photographs may be licensed/used by third parties for commercial reproduction whether on a paid for or free of charge basis.
- 2A Editorial purposes are defined as printed Newspapers,

Magazines, Books & Editorial Websites which are the on-line versions of bone fide newspapers and/or magazines; all other uses are deemed commercial. The usage and supply of pictures to any mobile services (MMS, G3 etc.) is prohibited unless approved as per paragraph 3.

- 2B No still photographic pictures or sequences of pictures may be used or modified in any way for the production/creation of a moving film or video, or any other type of moving image. Images may not be used as part of sequence streaming or images or which in anyway emulate moving pictures.
- 2C No shooting of video or moving image film may be undertaken by any Photographer or support staff attending The Championships.
- 3 Commercial exploitation of the photographs beyond that set out in paragraph 2 is only possible if *written approval* from the Club is obtained. This will be on terms to be negotiated in good faith between the Club and the Photographer.
- 4 Photographer must not allow the use of photographs, nor represent his/her own status or that of his/her agencies and/or their clients, in such a way as to imply any official commercial relationship between any commercial entity and the AELTC, unless otherwise agreed in writing with the AELTC.
- 5A Photographs may not be altered or manipulated

(electronically or otherwise) in such a way as to misrepresent actual events or to superimpose, remove or alter any advertising or promotional material.

- 5B Images are not to be used in association with (or positioned or juxtapositioned with) any marks, names or logos of any third party (commercial or otherwise) as to imply an official association where none exists.
- 6 Photographer is prohibited from reporting to third parties outside the venue of The Championships (whether by mobile phone or otherwise) any scoring or statistical information relating to play at The Championships whilst the match in question is being played, for ultimate use on a premium telephone results line or on an internet site service other than as part of a description of any photographs being disseminated in accordance with this accreditation.
- 7 The Club requests that the Photographer will provide copies of selected photographs taken by him/her for internal display, promotional use in the Club's publications and on the Club's official website at no charge, such requests not to be unreasonably withheld. All pictures where possible will be bylined. A handling charge to cover prints or CD's etc. ordered will be paid if required. If photographs are required for commercial exploitation by the Club, normal reproduction fees will apply.
- 8 When dealing with officials, all Photographers

should understand that many of these are working in an honorary capacity. Officials should offer their assistance with photographic matters where necessary or when requested. Any difficulties or dispute must at all times be addressed in the first instance to the Photograph Liaison Manager.

- 9 Whilst on court Photographers may not under any circumstances speak or communicate in any way with a player during a match.
- 10 Photographers may not inhibit or delay a player whilst moving from court to court by photographing or obstructing the route.
- 11 Photographers should be aware that whilst on court any request made by the chair umpire must be obeyed and no communication of any type with court officials, umpires, ball boys etc. is allowed.
- 12 In cases where a spectator is found to be occupying a photo position, please ask him/her politely to move. If your request is denied always ask for the assistance of the Steward/Security Guard controlling the area in question.
- 13 To ease movement around the courts, photographers may use the car lane in front of the clubhouse; however no photographs are to be taken from the car lane.
- 14 Passes are issued solely for the purpose of press photographic coverage of The Championships and must be displayed at all times.

- 17 Television cameras are not to be obstructed.
- 18 Photography of the Royal Box is only allowed if carried out discreetly with the emphasis on arrival and departure. If seated on platform B or on the court for on-court presentations no photographs may be taken of the Royal Box.
- 19 No photographic positions are available on the practice courts. However, pictures may be taken from the adjacent public areas.
- 20 No brightly coloured clothing or clothing bearing any kind of advertising or excessive branding may be worn.
- 21 All cameras to be used must be approved by the Photograph Liaison Manager. No excessively noisy equipment will be approved. The use of motor drives and rewind must not be used before the serve and used with discretion at other times.
- 22 No Flash or Strobe equipment may be used during play under any circumstances.
- 23 Photographs are only to be taken from approved photo positions or those designated by a tournament official.
- 24 There is no access to roofs, stands, scoreboards, water

towers etc. and photographs are not to be taken from the aisles, corridors etc. of show courts.

- 25 Movement into and out from photo positions may only take place during the change of ends.
- 26 Only one Photographer is permitted from each organisation/publication on each court.
- 27 No photographs are to be taken in the interview rooms.
- 28 Under no circumstances are photographs to be taken when using the underground service tunnels connecting the Media Centre and Court No.1.
- 29 When working in the photo positions you must respect and not infringe, impede or obstruct your fellow Photographers.
- 30 All Photographers attending The Championships must be covered by third party liability insurance, with coverage of not less than £5 million. By attending The Championships, the Photographer in so doing certifies that the appropriate cover is in place. All Photographers must be prepared to produce the document on request during their attendance. Failure to produce this document on request may result in accreditation being withdrawn.
- 31 The use of wireless computers or cameras is prohibited within the Grounds unless approved by the Photograph Liaison Manager.
- 32 Laptops may not be used in Photo Positions

without special dispensations from the Photograph Liaison Manager.

- 33 The network access points now available in the photographers' pits on Centre and No.1 Courts may only be used by photographers who have been specifically authorised to do so by the Photograph Liaison Manager.

## SECURITY

During The Championships, The Broadcast Centre is a very busy place with hundreds of people coming and going every day.

A network of sophisticated digital CCTV cameras is deployed throughout the building and the images from these are monitored and continually recorded 24 hours a day. In addition regular security patrols and inspections are conducted in all areas.

However it remains important that everyone working in the Broadcast Centre takes all necessary precautions to ensure the security of personnel and property.

Please read the following guidelines and ensure that all staff follow this advice.

- ★ If you see anyone acting suspiciously or see anyone without a proper form of accreditation, please report this to one of the security staff or the Broadcast Liaison Office without delay. Please understand the importance of security staff checking passes, wear them prominently at all times and please co-operate with them.
- ★ It helps to keep equipment secure if you make a list of all the items you have brought into your area. It also helps keep track if specific individuals are made responsible for the security of particular items.
- ★ Make sure no small, easily concealed items like computers, cameras, tape players etc. are left

unattended. Make sure you have the facility to lock things away securely.

- ★ De-rig is a particularly vulnerable time.
- ★ Please do not leave valuable items in the Broadcast Centre for use next year.

Championship identification label. These are issued by the Broadcast Liaison Office and are not transferable. The label must bear the name of the broadcaster for which it is operating, not simply the production company (see page 114 for example).

- ★ Accredited camera crews, except news access crews, may operate within the public areas up to 10.30 a.m. each day. Beyond 10.30 a.m. crews are generally restricted to operating from the designated camera platforms and require the relevant pass that is issued for a specified period by the Broadcast Liaison Office.
- ★ Requests for other access, including Aorangi Terrace, general shooting and practice courts, must be specifically agreed with the Broadcast Liaison Office. We will do our very best to accommodate all legitimate requests, but issues of space, safety and the interests of the public will be considered. Such crews will be accompanied at all times by a member of the Broadcast Liaison Office staff.

In particular the Covered Courts are very limited for space and facilities. In general, access will only be granted when wet weather has restricted outdoor practice. In those circumstances only two camera operators will be permitted at any one time and a strict time limit will apply—generally fifteen minutes each. As always the relevant Platform Pass will be required and the time restrictions will be set when the pass is issued by the Broadcast Liaison Office.

- ★ TV staff should ensure they do not wear light coloured clothing or do anything that may distract players or interfere with the enjoyment of spectators.
- ★ Crews are not permitted to take shots of the Royal Box when members of The Royal Family are present except on their arrival, departure and when presentations are being made.
- ★ Broadcasters may allow non-accredited visitors into the Broadcast Centre for the purposes of interview or other legitimate reasons with the specific permission of the Broadcast Liaison Manager or his deputy. Such visitors must wear an official wristband at all times. These wristbands do not admit to the Grounds, they are intended for use by people who already have means of admission to the Grounds (either by ticket or other official form of accreditation) who do not have Broadcast Centre accreditation and who are required in the Centre for a short time. Details of how to obtain the wristbands are available from the Broadcast Liaison Office.

#### **AELTC WORLD FEED & EUROPEAN FEED**

Networks are invited to make their requests known well in advance to either Mervyn Hall (Broadcast Liaison Manager), or IMG's representative, Nick Chesworth. (See page 124 for more information on World Feed.)

#### **CABLES FROM OSCAR**

All companies should contact the Broadcast Liaison

Office, for advice on the running of all cables from Oscar to their production areas.

#### **CABLING**

Each production and studio module has a cable access-way into the corridor. Once in the corridor, a system of cable hooks is provided on which to run cables. Provision is made at regular intervals for cables to pass between levels.

For connections to vehicles parked in the vehicle compound, cable access-ways have been provided at low level in the Loading Dock, with direct access to the middle level.

#### **CABLE ACCESS TO CENTRE & NO.1 COURT**

For Centre Court and the southern courts, this is at the basement level into the Buggy Route at the southern end of the building, via a cable trench, picking up the existing cable hooks in the north east hall of Centre Court.

For No.1 Court this is via the basement through the lightwell alongside the Restaurant, and into the Buggy Route, where routes are provided to courtside and the high level commentary boxes.

#### **CLEANING**

The Club has made arrangements for cleaning all media working areas.

Commentary boxes remain the responsibility of the allocated company, and we suggest you make arrangements for a daily tidying up of such working areas, bearing fire

risks especially in mind. Rubbish bags will be cleared periodically from inside working areas.

*During the rigging and de-rigging periods the Club will provide one skip and one compactor for the collection of rubbish, which will be collected twice daily to be situated beside the southern entrance to the Broadcast Centre.*

Rubbish bags will be issued to all companies, for collection from inside working areas on a regular basis. Do not place these bags in the corridors.

### EQUIPMENT STORAGE

Corridors must be kept clear at all times.

Equipment, including flight cases etc, must be kept within production offices or studios or in the allocated cabins now situated in Car Park 4. For full details contact the Broadcast Liaison Office.

### FIRE STOPPING

- ★ Once cabling to production and studio areas has been completed, the voids remaining will be fire-stopped using intumescent bags. During a fire, these bags expand and pack the space to prevent the fire spreading. Once this has been done the bags are not to be removed or adjusted without the Club's agreement.
- ★ Each level of the Broadcast Centre is fitted with smoke detectors and a fire alarm system. The two lower levels of the building are also protected by a sprinkler installation.
- ★ Hand-held fire fighting appliances and instructions

on how to use them will be issued by the Club, and these should be positioned in accordance with the Fire Officer's recommendations. You should ensure your staff know how to use them in an emergency.

- ★ The corridors are the escape routes in case of an emergency and must be kept clear of obstruction and any potential fire hazards at all times.

### HEALTH & SAFETY

- ★ TV companies are requested to pay special attention to health and safety matters.
- ★ **SMOKING IS FORBIDDEN IN ANY AREA WHICH IS UNDERCOVER OR INDOORS. THIS INCLUDES ALL OF THE BROADCAST CENTRE, OR IN ANY OF THE TELEVISION AND RADIO COMMENTARY BOXES ON CENTRE COURT AND NO.1 COURT. A SMOKE DETECTOR SYSTEM HAS BEEN INSTALLED. ANYONE FOUND SMOKING MAY HAVE THEIR ACCREDITATION WITHDRAWN.**
- ★ *No cooking will be permitted in any area other than designated pantries. This includes microwaves, kettles and coffee machines.*
- ★ A first-aid kit is available from the Broadcast Liaison Office.

### INSURANCE

The Broadcast Centre is covered by the Club's overall property insurance policy. Whilst every care will be taken to ensure the safe-keeping of goods and equipment

brought in or delivered by outside users, the Club cannot accept responsibility for any losses, shortages or breakages. Broadcast companies must accept full responsibility for checking in and checking out all items. See Security section page III.

The Club reserves the right to charge the broadcast company or companies concerned with any direct or consequential costs not recoverable through the insurance policy for any damage caused to the building or Broadcast Centre equipment.

★ *The Club cannot be held responsible for any loss of equipment or personal possessions.*

#### KEYS

Keys to allocated working areas and the storage cabins in Car Park 4 should be collected and signed for from the TV Liaison Office at the beginning of the tournament and returned at the end. Companies will be liable for a £75 fee for lost or non-returned keys.

#### LOADING BAY

Equipment and furniture can be off-loaded onto the scene dock and through designated doors along corridors directly to the studio areas. The transportation of items to the lower and middle levels will be via one of three lifts. The lifts have a loading capacity of 2,500 kg.

#### MUSIC

A CD copy of the Club's Official Musical Theme is available from the Broadcast Liaison Manager. When you use

the official music in your programmes the Club requires all broadcasters to deliver to the Broadcast Department following The Championships, a full and completed music cue sheet for all broadcasts which incorporate or include the instrumental theme "Purple and Green".

This cue sheet should reflect the following points:

1. Title: "Purple and Green"
2. The Composer: Tony Cox
3. The Publisher: EMI Music Publishing UK
4. The duration of usage

Each dubbing must be reported as a separate item. The requirement to inform the Club is in addition to the usual reporting your company makes to your local collecting society (Performing Rights Society).

#### PARKING & ACCESS

##### OUTSIDE BROADCAST VEHICLES

The outside broadcast vehicle parking area has been allocated to the BBC as host broadcaster, NBC and NHK. No other company has been allocated a space.

*All vehicles are to report to Car Park 1 off Marryat Road for access to the Broadcast Centre during the two weeks before and one week after The Championships. In order to avoid congestion, access will not be possible from the Somerset Road entrance. From Gate 1 in Church Road all vehicles will be directed through the tunnel to the Loading Bay area in the OB vehicle park.*

*Please observe the maximum speed of 5 m.p.h. in the tunnel.*

News Access at The Championships is intended to allow broadcasters to produce short, contemporaneous news items of matches played at The Championships. Match coverage should be taken from BBC TV Sport in London or the appropriate rights holder in your territory.

There are many countries in which one network holds the copyright to The Championships. In each of these countries you must negotiate with the copyright holder directly for the terms on which the news access material may be transmitted in that country.

This means:

- a) agreement to show such material;
- b) transmission times and frequency of transmission of such material;
- c) duration of such material transmitted;
- d) breakdown of such material, for example, play and/or interviews;
- e) a mandatory on-screen display of the AELTC Championships logo.

In most countries it is accepted that news access means a

maximum of three transmissions of two minutes in any one playing day broadcast in regularly scheduled news bulletins only. Live broadcasting is not permitted.

Broadcasters with a News Access agreement may not attach a sponsors name to their bulletins, nor may they sub-license footage.

### PLAYER INTERVIEWS

Player interviews, including post-match “flash” interviews, constitute part of the news access facility provided by The All England Lawn Tennis Club and the television transmission of these interviews is subject to the same copyright restrictions as play.

News Access reporters will have access to the Main Press Interview Room and can take part in the general, post-match conferences but may not bring their own cameras into the area. Broadcasters are responsible for arranging recording of such interviews in advance. Advice and guidance is available from the Broadcast Liaison Office.

### SCENE SETTER & OTHER STORIES

These must be shot on Monday 21st June. Shooting is permitted in the Club Grounds until 6.00 p.m. on that day only and will be conducted under guidance provided from the Broadcast Liaison Office. Particular restrictions regarding location, timing and other details, may be imposed but no filming of play or practice of any kind will be permitted or implied by this access right.

After the first day of The Championships, no cameras will be permitted in the AELTC precincts without prior approval from the Broadcast Liaison Manager.

Such approval is intended to allow local and regional broadcasters to cover stories of particular interest to their areas. It will generally be restricted to coverage of specific, non-Championship items such as profiles of individual junior players or other subjects of specific local interest to the broadcaster concerned.

Such filming must be confirmed and approved by the Broadcast Liaison Office and the BBC in advance and may be subject to specific restrictions.

#### INTERNET

TV news access granted does not include the right to transmit any video or audio material, live or recorded, on the Internet.

#### FEE

The news access fee for the 2010 Championships is £6,000 +v.a.t. which is payable before the start of The Championships. A full copy of the agreement is available from the office of the Broadcast Liaison Manager.





## EMERGENCY PROCEDURES

### EVACUATION

Any evacuation will normally be announced through the AELTC public address system.

*If you are asked to evacuate a court, an area of the Grounds, leave by the nearest exit or as directed by uniformed stewarding staff.*

In the event of a partial or total evacuation requiring you to leave the Grounds you should, in the first instance, move to Car Park 4 in Somerset Road. If you are then evacuated further, beyond safe Police cordons, you should report to the Wimbledon Club (Sports Hall) or as directed by the Police, where officials of the AELTC will advise you of the situation and any further action.

### EVACUATION

#### ONCE PLAY HAS STOPPED FOR THE DAY

*If the fire alarms are heard 30 minutes after play has been completed or suspended for the day, you are required to evacuate the Press Centre/Broadcast Centre immediately and go to the assembly point inside the Grounds—at the Rose Arbour—South West corner of No.1 Court, in between Courts 19 & 14.*

*Do not re-enter the building(s) until you have been advised to do so by London Fire Brigade or senior management from Group 4 Securicor.*

## CONDITIONS OF ENTRY

Entry to the Grounds of The All England Lawn Tennis & Croquet Club (AELTC) requires a valid ticket or pass, which **MUST** be retained at all times and implies acceptance of the following conditions which have been established for the safety and enjoyment of all our visitors and may be amended from time to time:

### SECURITY

The AELTC reserves the right to limit items which may be brought into the Grounds and to search bags, vehicles and the person before granting entry to the Grounds and other specific facilities.

### PROHIBITED ITEMS

The following items are prohibited from the Grounds of the AELTC:

- ★ any bag exceeding 18" x 12" x 12" (45cm x 30cm x 30cm); hard-sided items of any size;
- ★ any item which may be interpreted as a potential weapon including sharp or pointed objects (e.g. knives, large corkscrews) and 'personal protection' sprays;
- ★ large flags (over 2' x 2'), banners, rattles, klaxons or oversized hats;
- ★ any objects or clothing bearing political statements or commercial identification intended for 'ambush marketing'.

Visitors in possession of prohibited items may be refused entry or ejected from the Grounds. Prohibited items may be left in the Left Luggage facilities outside the Grounds or handed to AELTC security staff for disposal.

### ALCOHOL & REFRESHMENTS

Alcohol may be brought into the Grounds but is limited to the equivalent of one bottle of wine or two 500ml cans of beer per person. The consumption of alcohol is permitted only in public bars and other authorised areas. Glass drinking vessels may not be used on the Show Courts; all drinks taken onto the Show Courts must be covered to avoid spillage. Hot and/or strong smelling food may not be taken onto the Show Courts. The AELTC reserves the right to refuse entry to the stands of any court to anyone carrying alcohol and to ask anyone drinking alcohol in the stands to leave.

### BEHAVIOUR

The use of any annoying or dangerous behaviour, foul or abusive language, obscene gestures, the removal of shirts or any clothing likely to cause offence and the climbing onto any building, wall or other structure/equipment and the use of wheeled footwear is forbidden and may result in ejection from the Grounds.

### COURTS

Unauthorised persons are not permitted on the courts at ANY time.

### PHOTOGRAPHY

The use of photographic equipment must not inconvenience any other person in the Grounds. Still photographs, film, videotape or other audio-visual material recorded within the Grounds may not be sold or used commercially in any way whatsoever unless authorised by the AELTC and may be confiscated by the Club if such sale or commercial use is suspected.

### MOBILE TELEPHONES, COMMUNICATION DEVICES & RADIOS

The use of mobile telephones, communication devices or radios must not inconvenience any other person in the Grounds; in particular they must be SWITCHED OFF in and around the courts in play. Personal headphones must be used when listening to radios inside the Grounds.

### TICKETS

Championships tickets may not be bought, sold or distributed without lawful authority.

### FILMING & BROADCASTING AT THE CHAMPIONSHIPS

During the Wimbledon fortnight, various filming, photography and broadcasting takes place. By your presence at The Championships, you grant your permission for your likeness and voice to be included on film and their exploitation and advertising without compensation or credit.

THE AELTC RESERVES THE RIGHT FOR ITS SERVANTS, AGENTS AND POLICE OFFICERS TO REMOVE FROM THE GROUNDS ANY PERSON WHO CONTRAVENES THE ABOVE 'CONDITIONS OF ENTRY' AND ANY PERSON WHOSE PRESENCE AND/OR BEHAVIOUR IN THE GROUNDS COULD REASONABLY BE CONSTRUED AS DANGEROUS, A NUISANCE OR ANNOYANCE TO ANY OTHER PERSON IN THE GROUNDS.
